

# BACKYARDS AND BASEMENTS BILLIARD DELIVERY & INSTALLATION AGREEMENT

I \_\_\_\_\_ agree to contract backyards and basements, for the delivery and installation of my billiard table package.

## **BILLIARD DELIVERY & INSTALLATION INCLUDES THE FOLLOWING:**

**INT**

1. Delivery of billiard table.
2. Complete assembly and leveling of table.
3. Installation of cloth on rails and table.
4. Delivery of accessory kit. (play package)
5. Travel to job site within 30 miles of store.
6. Placement of billiard cartons in customer's designated garbage area.
7. A 90-day warranty on leveling and craftsmanship of the installation. (Moving the table during this 90-day period voids this warranty.)

## **NON-STANDARD DELIVERY AND INSTALLATION CHARGES:**

**INT**

1. Stairs: (35.00 per set) A set of stairs is 5 steps.  
**If you should wish the installer to go another route without using the stairs it must be safe!**
2. Extra charges apply for the following: The installation of any other products purchased, any tasks requested other than the installation of the pool table itself, furniture being moved, or placement of rug under table is considered extras.

## **MILEAGE CHARGES:**

**INT**

Mileage charges will be assessed at \$1.50 per mile, one way, on any distances exceeding 20 miles from the store of purchase.

## **CUSTOMER/HOMEOWNER RESONSIBILITIES:**

1. The customer/home owner is aware of and accepts the responsibility for all permits or permission where required.
2. The customer/home owner agrees to make any possible preparations for delivery, including removal of any furniture, throw rugs, plants, etc., that fall within the delivery and installation site.
3. The customer/home owner agrees to have clear access and ample room to work around the billiard table.
4. Customer also understands they are responsible for supplying electricity to installer for installation of the table.

➤ **All additional charges are due upon completion of delivery and installation**
